2.1 Harmonization of Transit Shelter Agreements.

The Works Committee had before it a communication (December 1, 1999) from the City Clerk advising that the Committee, at its meeting on December 1, 1999, had before it a report (November 29, 1999) from the Commissioner of Works and Emergency Services recommending that:

- (1) it be the goal of the City over time to have a single agreement for advertising on transit shelters;
- (2) in order to move towards a single agreement and open the process to public tendering within a reasonable time frame, staff be directed to negotiate with Mediacom Inc. to extend the existing Metro and North York agreements to 2005 (the year the Toronto agreement expires) in return for additional benefits to the City including but not limited to elimination of existing District 3 costs; and
- (3) staff report back on the results of the negotiations;

and further advising that the Committee deferred consideration of the aforementioned report and the following motion until its next meeting, scheduled to be held on January 12, 2000, as a deputation item:

“That the report be adopted, and further that the Commissioner of Works and Emergency Services be requested to:

- (1) consider the results of the Request for Proposals process in Mississauga as part of the negotiations;

- (3) the appropriate City of Toronto officials be directed to take the necessary action to give effect thereto.

- (1) the process of eliminating duplicate and triplicate street names on the basis of minimum number of occupants on the streets to be renamed, tentatively identified in Attachment No. 1, be approved in principle;

- (3) once a policy for the selection of street names has been adopted by City Council, the affected ratepayer groups and local associations be notified of the foregoing and be requested to submit an appropriate name for the street to be renamed; and

- (1) traffic control signals be installed on Dundas Street West at the access to the IGA-Price Chopper supermarket at 2440 Dundas Street West, north of Chelsea Avenue in conjunction with the opening of the supermarket; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Works Committee had before it a report (December 8, 1999) from the Commissioner of Works and Emergency Services recommending that construction of a pedestrian refuge island on Sheppard Avenue East approximately 34 metres east of the driveway to 4725/4727 Sheppard Avenue East proceed in the year 2000.

- (2) that authority be granted to commence advertising for the highway alteration, and that deputations with respect thereto be made to the Scarborough Community Council.

**2.8 Request for Opening in Landscaped Centre Median -
Andrews Motel, 2245 Kingston Road.
(Scarborough Bluffs)**

The Works Committee had before it a report (December 8, 1999) from the Commissioner of Works and Emergency Services respecting a request by the Andrews Motel to former Metro Transportation for an opening in the landscaped centre median at 2245 Kingston Road to attract business; reporting on information gathered through consultation with Councillor Brian Ashton, property owners and members of the public regarding the request; advising that a continuous median has restricted access to right-in/right-out movements for properties along Kingston Road in the vicinity of the Andrews Motel for at least 45 years; concluding that given that an investment has been made in recent years by providing streetscape enhancements and the benefits are now being enjoyed by the community, it is difficult to justify providing an opening in the median for individual property owners and businesses; and recommending that this report be received and forwarded to Council for its information.

2.9 Installation and Maintenance of Traffic Signs on Arterial Roads and Expressways within the City of Toronto for the Period April 1, 2000 to March 31, 2002, Contract No. T-95-99, Tender Call No. 282-1999.

The Works Committee had before it a joint report (December 6, 1999) from the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer recommending that:

- (1) Contract No. T-95-99, Tender Call No. 282-1999, for installation and maintenance of traffic signs on arterial roads and expressways within the City of Toronto for the period April 1, 2000 to March 31, 2002, be awarded to Mark-All Services Inc., in the amount of \$1,201,914.95, including all taxes and charges, being the lowest Tender received; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Committee awarded the contract as recommended in the aforementioned joint report, in accordance with By-law No. 57-1998, the Interim Purchasing By-law, as amended.

2.10 F. G. Gardiner Expressway – Concrete Substructure Repairs, Sherbourne Street to Jarvis Street, Contract No. T-33-99, Tender Call No. 9-1999.

The Works Committee had before it a report (December 15, 1999) from the Commissioner of Works and Emergency Services recommending that the cost of Contract No. T-33-99, Tender Call No. 9-1999, for the concrete substructure repair to the F.G Gardiner Expressway from Sherbourne Street to Jarvis Street, be increased by \$26,046.11 to a total of \$4,521,690.46 (GST inclusive) to cover the costs incurred for work done under this contract including additional unforeseen repair work.

The Committee recommended to Council the adoption of the aforementioned report.

**2.11 Mississauga Transit Buses on
Burnhamthorpe Road.**

The Works Committee had before it a report (October 18, 1999) from the City Solicitor respecting the recommendation of the Urban Environment and Development Committee that a by-law be enacted prohibiting Mississauga Transit buses from using Burnhamthorpe Road east of Highway 427, and that the Minister of Transportation be requested to approve the passing of such a by-law, which was adopted by Council on April 13, 14 and 15, 1999; advising the Committee that the Minister has refused to approve the by-law on the grounds that it is not in the best interests of either the City of Toronto or the City of Mississauga to approve such a by-law at this time, and that the Minister has suggested that the Greater Toronto Services Board could assist the parties to arrive at a workable solution to this matter, and forwarding a copy of the Minister's response; and recommending this report be received for information.

- (1) deferred consideration of the aforementioned report and following motion until its next meeting, scheduled to be held on January 12, 2000:

“That the source-separated organics pilot project proceed first”; and

- (2) requested the Commissioner of Works and Emergency Services to submit a report to such meeting on:
 - (i) a breakdown of the estimated costs for the project; and
 - (ii) the volume of mixed waste and source-separated organic tonnage that can be handled by the pilot facility and by the expanded facility.

- (4) for 2002, twice-a-week summer curbside garbage collection be implemented in Etobicoke, East York, York and Scarborough.

The Committee also had before it the following communications:

- (i) (December 7, 1999) from the Mr. Gordon and Mrs. Barbara Bonn, Toronto, Ontario, expressing strong opposition to twice-a-week garbage pickup, and suggesting instead that the Works Committee seriously consider biweekly pickup; and
- (ii) (January 11, 2000) from Ms. Karen Buck, Toronto, Ontario, with respect to diversion initiatives instead of summer twice-a-week collection.

Councillor Layton moved that the Committee no longer support the concept of twice-a-week garbage collection. **(Lost on tie vote)**

agreed reporting and evaluation system and an understanding of what affect funding levels from others will have on the deliverables.

2.20 Children's Water Institute.

promotional campaign encouraging residents to bring their household hazardous waste to the City's year 2000 Environment Days; the \$340,000.00 being comprised of \$100,000.00 for promotion and \$240,000.00 for the collection, recycling and disposal of the increased quantity of household hazardous waste projected to be recovered; and

- (2) subject to a funding commitment of \$340,000.00 from the Waste Diversion Organization by March 10, 2000, the Department implement an intensive promotional campaign aimed at encouraging residents to bring their household hazardous waste to the City's year 2000 Environment Days.

The Committee recommended to Council the adoption of the aforementioned report.

2.25 Keele Valley Landfill Site – Amendment to Consulting Agreement with Conestoga Rovers & Associates Limited.

- (1) authority be granted to increase the approved level of expenditure for technical services for Conestoga Rovers & Associates Limited by an amount of \$278,773.00, including the Goods and Services Tax (\$268,351.25 after the Municipal Goods and Services Tax Rebate), for general engineering and consulting services, landfill gas consulting services including gas utilization, leachate handling, stormwater management, moisture recirculation, final cover, progressive rehabilitation and site closure requirements at the Keele Valley landfill Site;
- (2) the term of the Agreement be extended to December 31, 2002; and
- (3) the appropriate officials be authorized to amend the existing Agreement between the City of Toronto and Conestoga Rovers & Associates Limited to give effect thereto.

The Committee recommended to Council the adoption of the aforementioned joint report.

2.26 Keele Valley Landfill Site – Amendment to Consulting Agreement with Dixon Hydrogeology Limited.

The Works Committee had before it a joint report (December 16, 1999) from the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer recommending that:

- (1) authority be granted to increase the approved level of expenditure for consulting services for Dixon Hydrogeology Limited by an amount of \$510,000.00, including the Goods and Services Tax (\$490,934.55 after the Municipal Goods and Services Tax Rebate), for consulting services with respect to hydrogeological analysis at the Keele Valley Landfill Site;
- (2) the term of the Agreement be extended to December 31, 2002; and
- (3) the appropriate City officials be authorized to amend the existing Agreement between the City of Toronto and Dixon Hydrogeology Limited to give effect thereto.

The Committee recommended to Council the adoption of the aforementioned joint report.

2.27 Keele Valley Landfill Site – Amendment to Consulting Agreement with Golder Associates Limited.

The Works Committee had before it a joint report (December 16, 1999) from the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer recommending that:

- (1) authority be granted to increase the approved level of expenditure for consulting services for Golder Associates by an amount of \$318,017.00, including the Goods and Services Tax (\$306,128.62 after the Municipal Goods and Services Tax Rebate), to provide consulting services with respect to liner monitoring and reporting at the Keele Valley Landfill Site;
- (2) the term of the Agreement be extended to December 31, 2002; and

- (3) the appropriate City of Toronto officials be authorized to amend the existing Agreement between the City of Toronto and Golder Associates Limited to give effect thereto.

The Committee recommended to Council the adoption of the aforementioned joint report.

2.28 Interim Spending Approvals for the 2000 Water and Wastewater Capital Works Program.

The Works Committee had before it a report (January 6, 2000) from the Commissioner of Works and Emergency Services recommending that:

- (1) the Budget Advisory Committee be requested to recommend the approval of interim spending authority, in the amount of \$21,704,000.00 for the projects identified in Appendix "A", prior to the approval of the Water and Wastewater Service Division's 2000-2004 Capital Works Program; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Committee recommended to the Budget Advisory Committee the adoption of the aforementioned report.

2.29 Draft Environmental Plan – Acceleration of Investment in Sustainable Energy.

The Works Committee had before it a communication (December 22, 1999) from Councillor Jack Layton, Chair, Environmental Task Force, advising that the Environmental Task Force as its meeting held on December 20, 1999, considered the first draft of the Environmental Plan; and that the Environmental Task Force recommends that the City of Toronto and the Toronto Hydro

Electrical System Corporation seek approval from the Ontario Energy Board for the right to implement measures to support financing of sustainable energy, including:

- (1) the use of a surcharge (Systems Benefits Charge) applied to all Toronto Hydro customers, to generate funds that could be used to fund sustainable energy projects;
- (2) a Toronto Hydro rate structure based primarily on consumption rather than fixed service charges;
- (3) a Toronto Hydro net metering offering for customer generation of green power (including customer generation that is collectively owned); and
- (4) a rate mechanism for investment in sustainable energy similar to the load reduction adjustment mechanism applied to gas distribution utilities.

On motion by Councillor Sinclair, the Committee recommended to Council the adoption of the recommendations embodied in the aforementioned communication.

**2.30 Provision of Bicycle Parking with the Conversion
to Pay-And-Display On-Street Parking.
(All Wards)**

The Works Committee had before it a report (January 5, 2000) from the Commissioner of Works and Emergency Services responding to a communication dated November 26, 1999, from the Toronto Cycling Committee respecting the impact of the removal of parking meters on cyclists, which was before the Committee at its meeting on December 1, 1999; and recommending that on City of Toronto streets where pay-and-display machines have been installed or are being installed in the future to replace parking meters, replacement bicycle parking be provided according to the following principles:

- (1) Transportation Services determine the appropriate number and location of replacement post-and-ring bicycle stands, including reusing the existing meter posts where appropriate;
- (2) Transportation Services manage the installation and long-term maintenance of all replacement post-and-ring bicycle stands as part of its ongoing bicycle parking program;

- (3) the Toronto Parking Authority pay up to \$65.00 per post for the placement of bicycle locking rings on meter posts where the existing post can be reused and, where new posts are required, the Toronto Parking Authority pay up to \$65.00 per post and Works and Emergency Services pay any additional costs, over and above this amount; and
- (4) the Toronto Parking Authority pay for the installation of new post-and-ring bicycle stands in locations where parking meter posts have already been removed.

On motion by Councillor Layton, the Committee recommended to Council the adoption of the aforementioned report, subject to amending Recommendation No. (1) by adding thereto the following words:

“and that the framework used by departmental staff for such decisions be made in consultation with the Toronto Cycling Committee.”

2.31 Gardiner Expressway East Dismantling - Additional Consultant Fees for Design Work.

The Works Committee had before it a report (December 24, 1999) from the Commissioner of Works and Emergency Services recommending that additional design fees in the amount of \$237,565.00 be authorized for Cole Sherman & Associates Ltd. to complete the design for the Gardiner Expressway East Dismantling Project.

The Committee recommended to Council the adoption of the aforementioned report.

2.32 Exemption from Pay Permit Fees for the Installation of Banner Signs at Various Locations on City Streets.

The Works Committee had before it a report (January 5, 2000) from the Commissioner of Works and Emergency Services respecting a request to obtain an exemption from paying the permit fees for the installation of banner signs on 465 utility poles at various locations, for the period of January 15, 2000 to February 9, 2000, for the National Hockey League All-Star Game; and

recommending that the Works Committee decide whether to recommend to Council an exemption for the National Hockey League from paying the required permit fees for the installation of banner signs over City streets.

The Commissioner of Works and Emergency Services requested the permission of the Committee to withdraw the aforementioned report, which was granted.

The Works Committee had before it a joint report (January 11, 2000) from the Commissioner of Works and Emergency Services and the City Solicitor respecting the issue of the formality of the submission made by Ref-Fuel Canada Ltd. to the Toronto Integrated Solid Waste Resource Management Process (“TIRM”) Solid Waste Disposal Request for Proposals, as requested by the Committee at its special meeting held on January 10, 2000; and recommending that this report be received for information.

The Committee also had before it a confidential report (January 11, 2000) from the City Solicitor respecting the formality of the submission by Ref-Fuel Canada Ltd.

The Committee also had before it a communication (January 12, 2000) from Mr. Dave Gutacker, Chief Operating Officer, American Ref-Fuel Company, respecting the response of Ref-Fuel Canada Ltd. to the Solid Waste Disposal RFP; and the interpretation of the financial assurance letter that was submitted in Ref-Fuel’s proposal.

Mr. Derek Veenhof, Business Manager, Ref-Fuel Canada Ltd., appeared before the Committee in connection with the foregoing matter.

On motion by Councillor Layton, the Committee recommended to Council that the proposal submission by Ref-Fuel Canada Ltd. be excluded from any further consideration in the TIRM Disposal Request for Proposals process.

2.34 Sewer Use By-law.

The Works Committee had before it a communication (January 12, 2000) from Councillor Jack Layton, Don River, recommending that the Commissioner of Works and Emergency Services report to the next Works Committee meeting on the status of the sewer use by-law, including a revised timetable which has the Works Committee consider the proposed sewer use by-law and hear deputations on the proposed by-law in March 2000.
