11.1 Greater Toronto Airports Authority (City-wide)

11.2 Waterfront Heritage and Culture Plan (All Wards)

The Economic Development and Parks Committee had before it a report (September 28, 2001) from the Commissioner of Economic Development, Culture and Tourism, reporting on the Waterfront Heritage and Culture Infrastructure Plan for the central waterfront recently completed by the Culture Division; and recommending that:

- (1) the Central Waterfront Heritage and Culture Infrastructure Plan (Attachment No. 1) be adopted;
- (2) the Central Waterfront Heritage and Culture Infrastructure Plan be forwarded to the City's Waterfront Reference Group and to the governing body for waterfront development for review and inclusion in that corporation's business and development strategy;
- (3) the Commissioner of Economic Development Culture and Tourism be directed to commission a follow-up study to develop culture and heritage infrastructure plans for the eastern waterfront communities and the western waterfront communities so as to incorporate Toronto's entire waterfront into the Plan;
- (4) the cultural landscape of Toronto's waterfront be highlighted through the creation of a high profile cultural zone that will enhance national and international tourism and that work begin immediately to explore private and public sector support and

partnerships to develop the central waterfront cultural zone and the cultural corridors identified in the Plan, particularly John Street and Jarvis Street;

- (5) a preliminary strategic assessment be developed of the opportunity to create a cultural centre/museum strategy as a major tourist attraction and as a forum to showcase Toronto to Canadians and the world;
- (6) the Commissioner of Economic Development, Culture and Tourism be authorized to make an application to the Federal Cultural Spaces program for funding to undertake a strategic assessment;
- (7) recognized heritage properties, cultural landscapes and potential archaeological resources be identified and managed as important elements of waterfront revitalization; and
- (8) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (4) City Council authorize the Chief Administrative Officer to approve contingency expenditures for mosquito control, on the recommendation of the Medical Officer of Health;
- (5) the Board of Health, Economic Development and Parks Committee, and Works Committee refer this report for consideration in the 2002 Operating Budget process; and
- (6) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

11.18 Toronto Arts Council - Operating Principles

The Economic Development and Parks Committee had before it report (November 1, 2001) from Commissioner of Economic Development, Culture and Tourism, reporting on the implementation of a new grant agreement, based on an operational review of the Toronto Arts Council; and recommending that:

- (1) City Council reaffirm its decision of December 1998 regarding the Toronto Arts Council's mandate as an arm's length organization, to administer the distribution of arts and culture grants on behalf of the City of Toronto;
- (2) authority be granted to enter into a multi-year agreement with the Toronto Arts Council for the administration of the distribution of arts and culture grants subject to:
 - (a) the following Terms and Conditions:
 - (i) City Council has control over policy;
 - (ii) TAC will continue to report to City Council through the Economic Development and Parks Committee;
 - (iii) TAC will continue to submit its annual Grant Budget request to the Budget Advisory Committee; to allow staff comments on the request to be considered by the Committee at the same time, TAC will submit copies of the request to the Commissioner of Economic Development, Culture and Tourism, the Chief Financial Officer and Treasurer, and the City Auditor, as appropriate, prior to submitting to the Committee;
 - (iv) TAC will submit a description of planned granting activities and anticipated deliverables in its annual Grant Budget Request;
 - (v) the actual annual grant amount will be determined through the annual budget process; the annual Grant Budget Request submission would include separate requests for the Cultural Grants Program and for the Operations Program;
 - (vi) the request for the Operations Program would not exceed 10 percent of the total request budget; this percentage is to be proposed by the TAC on an annual basis, accompanied with clear rationale and justification; the percentage request and the actual amount of the Operations Program would be subject to the review and approval by City Council;

- (vii) TAC will manage its finances in accordance with established City fiscal policies and practices, including record keeping, budget monitoring and the return of unused City funds upon termination of services:
- (viii) TAC will submit quarterly and annual reports on its granting activities, including appropriate quantitative and qualitative overview of arts and culture activities funded, and other financial information for the preceding period, to the Committee, with copies to the Commissioner, the Chief Financial Officer and Treasurer, and the City Auditor;
- (ix) TAC will submit on an annual basis, audited financial statements to the Commissioner, the Chief Financial Officer and Treasurer, and the City Auditor, prior to submitting to the Committee;
- (x) TAC will submit Board minutes after each Board meeting to the Commissioner and the City Auditor;
- (xi) TAC will provide to the Commissioner an annually updated database of its grantees, containing pertinent financial and other information; and
- (xii) TAC will satisfy the City's insurance and indemnity requirements; and
- (b) the satisfaction of the Commissioner of Economic Development, Culture and Tourism, City Solicitor and the Chief Financial Officer and Treasurer;
- (3) the Economic Development and Parks Committee review the outstanding issues raised by the Toronto Arts Council and outlined in this report when considering the Terms and Conditions for the multi-year agreement:
 - (a) City Council Control over Policy;
 - (b) Termination Requirements;
 - (c) Access to TAC data; and
 - (d) Risk Management;
- (4) the City Solicitor be requested to clarify with the Ministry of Municipal Affairs, City Council's authority to delegate its powers generally under the new Ontario Municipal Act, 2001; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Councillor Joe Mihevc, Ward 21 St. Paul's, appeared before the Economic Development and Parks Committee in connection with the foregoing matter.

On motion by Councillor Minnan-Wong, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned report, subject to:

- (1) the report being amended to provide that the multi-year agreement with the Toronto Arts Council specify that the Toronto Arts Council continue to report to City Council through the Economic Development and Parks Committee; and further that, in order to ensure accountability and adherence to Council policies, procedures, and the terms of the Agreement, the TAC submit its reports to the Commissioner of Economic Development, Culture and Tourism in the timeframe established for Committee reporting so that the Committee can be provided with analysis and staff recommendations;
- (2) Recommendation No. 2(a)(vi) being amended by deleting the words "not exceed 10 percent" and inserting in lieu thereof the words "not exceed eight percent";

- (4) adding that the Agreement be signed upon receiving confirmation that the City Auditor is satisfied that TAC has satisfactorily addressed all issues raised in his report relating to Grants Programs.

- (2) authority be granted to introduce the necessary Bill in Council, substantially in the form of the draft by-law; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.
