- (4) subject to the City Clerk reporting favourably on the results of the poll referred to in Recommendation No. (2) and upon receipt of the legal description prepared by the Commissioner of Works and Emergency Services, the City Solicitor be directed to prepare a by-law designating the area as a Business Improvement Area, as described by Attachment No. 1 (Maps 1 to 3), in accordance with Section 220 of the Municipal Act; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Mammoliti, the Economic Development and Parks Committee recommended to City Council the adoption of the aforementioned report.

5.15 Intention to Designate the St. Clair-Bathurst Business Improvement Area (BIA) (Ward 21 St. Paul's)

- (3) the Commissioner of Works and Emergency Services be requested to prepare a legal description of the area, as described by Attachment No. 1 (Maps 1 to 4), and to submit this description to the City Solicitor;
- (4) subject to the City Clerk reporting favourably on the results of the poll, referred to in Recommendation No. (2), and upon receipt of the legal description prepared by the Commissioner of Works and Emergency Services, the City Solicitor be directed to prepare a by-law designating the area as a Business Improvement Area, as described by Attachment No. 1 (Maps 1 to 4), in accordance with Section 220 of the Municipal Act; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Mammoliti, the Economic Development and Parks Committee recommended to City Council the adoption of the aforementioned report.

5.16 Appointments to Fourteen Business Improvement Areas Boards of Management (Various Wards)

The Economic Development and Parks Committee had before it a report (May 7, 2002) from the Commissioner of Economic Development, Culture and Tourism, appointing nominees to the Bloor Annex, Bloordale Village, Bloor West Village, Downtown Yonge Street, Eglinton Hill, Greektown on the Danforth, Kingsway, Lakeshore Village, Liberty Village, Mimico Village, Mimico by the Lake, Queen Broadview Village, Roncesvalles Village and St. Clair West Business Improvement Areas Boards of Management and to amend the City of Toronto Municipal Code, Chapter 19, "Business Improvement Areas" as necessary; and recommending that:

- (1) Council appoint the Business Improvement Area Board of Management nominees for fourteen BIAs, as listed in Attachment No. 1, for the balance of the 2001-2003 term;
- (2) amendments be made to the City of Toronto Municipal Code, Chapter 19, "Business Improvement Areas", as outlined in Attachment No. 2, which identifies the number of board members that make up the board and the number of members required for quorum; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Moeser, the Economic Development and Parks Committee recommended to City Council the adoption of the aforementioned report.

5.17 Business Improvement Area Capital Cost-Sharing Program Review (All Wards)

- copies of the Old Town Toronto Revitalization Action Plan "Putting Old Town Toronto in the Spotlight", Attachment No. 1, be forwarded to appropriate staff in the Ministry of Economic Development and Trade, the Waterfront Project Secretariat, Heritage Toronto, the Ministry of Colleges, Training and Universities, Human Resources Development Canada and to interested parties in the St. Lawrence Neighbourhood Association, North Market Redevelopment Initiative, St. Lawrence Neighbourhood BIA, Queen East Business Association (QUEBA), West Don Lands Committee, Citizens for the Old Town, St. Lawrence Works Coalition, Corktown Residents and Business Association and the Gooderham and Worts Neighbourhood Association; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Councillor Feldman appointed Councillor Korwin-Kuczynski Acting Chair and vacated the Chair.

 - (a) Collections, Conservation and Shared Resources Management Board; and

- for a term of office commencing June 21, 2002 and expiring November 30, 2003, and until their successors are appointed;
- (2) having regard that The Pier Museum is now closed and the Board inactive, Council refrain from appointing Members of Council to The Pier Museum Management Board; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Augimeri, the Economic Development and Parks recommended that:

- (1) Councillor Chris Korwin-Kuczynski be appointed to the following Boards for a term of office commencing June 21, 2002 and expiring November 30, 2003, and until his successor is appointed;
 - (a) Fort York Museum Management Board; and
 - (b) Collections, Conservation and Shared Resources Management Board;
- (2) having regard that The Pier Museum is now closed and the Board inactive, Council refrain from appointing Members of Council to The Pier Community Museum Management Board; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

5.23 Authority for the Kew Play Community Group to Seek Private Donations for the Redevelopment of the Kew Gardens Playground (Ward 32 Beaches-East York)

The Economic Development and Parks Committee had before it a joint report (May 14, 2002) from the Commissioner of Economic Development, Culture and Tourism and the Chief Financial Officer and Treasurer, seeking Council authority for the Kew Play Community Group, as requested by Toronto East York Community Council, Clause No. 57 of Report No. 4, to seek private donations for the redevelopment of the Kew Gardens Playground and to grant the necessary authority for the Chief Financial Officer and Treasurer to issue receipts for income tax purposes to donors; and recommending that:

- (1) authority be given to the Kew Play Community Group, on behalf of the City of Toronto, to seek private donations for improvements to the playground at Kew Gardens;
- (2) Council establish an obligatory reserve fund called the "Kew Gardens Playground Reserve Fund" the purpose of which is to provide funding for the redevelopment of the Kew Gardens Playground;
- (3) Municipal Code Chapter 227 be amended by adding the "Kew Gardens Playground Reserve Fund" to Schedule B3, Donated Funds;
- (4) all donations received for the Kew Gardens Playground redevelopment, by the City of Toronto, will be held separately in the "Kew Gardens Playground Reserve Fund" designated for this purpose and receipts for income tax purposes will be issued to donors in accordance with the Income Tax Act; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Augimeri, the Economic Development and Parks Committee recommended to the Policy and Finance Committee, and City Council, the adoption of the aforementioned joint report.

(1) \$0.130 million previously approved to redevelop the East Point Soccer Field (CPR116-31-07) be deleted and funding be reallocated with \$0.080 million for the Adams Park Fieldhouse development sub-project (CPR116-31-05) and \$0.050 million for the Port Union Skateboard development sub-project (CPR116-31-06);

- (2) the FY2002 Tree Advocate capital account (CPR124-32-01) revenues and expenses be increased by \$0.104 million to account for the additional donations received to date;
- (3) the previously approved 2001 Ashbridges Bay Water Play account (CPR119-31-02) be closed and the balance of \$0.146 million be reallocated with \$0.110 million for a change in scope to the Woodbine Park Play/Water Play area (CPR119-32-07) and \$0.036 million to the CSA Playground Rehabilitation Project for the Kew Beach Play area development (CPR119-31-07);
- (4) the FY2002 Council approved Capital sub-project for a waterplay facility at Cruickshank Park (CPR119-32-07), in the amount of \$0.250 million be deleted and the funding and account number be reallocated to construct a waterplay facility in the adjacent Weston Lions Park;
- (5) a new Eglinton-Brentcliffe Park Development account (CPR 117-32-08) be created with revenues and expenses of \$0.300 million funded from a Section 37 agreement and that approval be given to receive the funds into this account; and
- (6) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Councillor Joe Pantalone, Ward 19 Trinity-Spadina, appeared before the Economic Development and Parks Committee in connection with the foregoing matter.

- (3) the City and TEDCO continue to work in partnership to support the bio-medical incubator project with the MARS medical and related sciences non-profit corporation;
- (4) Council endorse TEDCO's support of the MARS project as a component of its incubator/commercialization objectives and TEDCO's plan to identify opportunities for assisting with its implementation subject to the approvals of the TEDCO Board; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Minnan-Wong, the Economic Development and Parks Committee:

- (1) recommended to City Council the adoption of the aforementioned report; and
- (2) requested the Commissioner of Economic Development, Culture and Tourism to provide a presentation on the MARS project at the Economic Development and Parks Committee meeting on June 27, 2002.
