10.1 Woodbine Park Special Events - Status Report (Ward 32 Beaches-East York)

The Economic Development and Parks Committee had before it a report (September 26, 2002) from the Commissioner of Economic Development, Culture and Tourism, Reporting, as requested by Council at its meeting on April 16, 17 and 18, 2002, on the plan to move special events and festival activities from Kew Gardens Park to Woodbine Park; and recommending that:

- (1) all major events be moved to Woodbine Park for 2003 and smaller scale events continue to operate in Kew Gardens Park;
- (2) the Commissioner of Economic Development, Culture and Tourism in consultation with the local Councillor, the event organizer(s) and the various community stakeholders work towards clearly defining the scope and size of special events that will take place in Kew Gardens Park for 2003 and onward; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Economic Development and Parks Committee also had before it during consideration of the foregoing matter the following report and communications:

- (a) (November 20, 2002) from the Commissioner of Economic Development, Culture and Tourism, reporting on the Woodbine Park Bandshell Assessment commissioned by the Beaches International Jazz Festival, as requested by the Economic Development and Parks Committee at its October 10, 2002 meeting; and recommended that this report be received for information.

 - (c) the report (September 26, 2002) from the Commissioner of Economic Development, Culture and Tourism be received; and
 - (2) receive the report (November 20, 2002) from the Commissioner of Economic Development, Culture and Tourism for information.

- (3) this report be forwarded to the Economic Development and Parks Committee for its consideration and approval of the "Policy Framework for Memorials on City Parks and Open Spaces", Attachment "B", to this report;
- (4) all inquiries relating to memorials on City owned parkland or open spaces be directed to the Commissioner of Economic Development, Culture and Tourism or his/her designate; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.
- (b) (November 21, 2002) from the Commissioner of Economic Development, Culture and Tourism, responding to the request by the Economic Development and Parks Committee for further information on various aspects of the proposed policy guidelines for both temporary and permanent memorials; and recommending that this report be received for information.

The City may approve the planting of a tree or trees within the road rights-of-way at, or near, the site of the tragic event, at full cost recovery to the requestor and subject to the approval of the Commissioner of Economic Development, Culture and Tourism and the Commissioner of Works and Emergency Services, or his/her designates and any adjacent property owner(s). Where applicable, the full benefits of the Tree

Advocacy Planting Program will apply to the planting of memorial trees.":

- (b) that all inquiries relating to memorials on City owned parkland or open spaces be directed to the Commissioner of Economic Development, Culture and Tourism or his/her designate;
- (c) that Section 3.3 of the proposed "Policy and Procedural Guidelines for Memorials on Public Road Rights-of-Way" be amended to read as follows:
 - "3.3 Upon request for a permanent memorial within a road right-of-way, the City will advise of the benefits of the Tree Advocacy Planting Program. The City may approve the planting of a tree or trees within the road rights-of-way at, or near, the site of the tragic event, at full cost recovery to the requestor and subject to the approval of the Commissioner of Economic Development, Culture and Tourism and the Commissioner of Works and Emergency Services, or his/her designates and any adjacent property owner(s). Where applicable, the full benefits of the Tree Advocacy Planting Program will apply to the planting of memorial trees."; and
- (d) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto; and
- (2) received the report (November 21, 2002) from the Commissioner of Economic Development, Culture and Tourism for information.

10.4 Toronto Heritage Fund Grant 140 Princes' Boulevard (Formerly 2 Strachan Avenue) Horse Palace, Exhibition Place (Ward 19 Trinity-Spadina)

The Economic Development and Parks Committee had before it a report (November 19, 2002) from the Commissioner of Economic Development, Culture and Tourism, seeking Council's approval of the Toronto Heritage Grant award for 140 Princes' Boulevard; and recommending that:

- (1) the Toronto Heritage Grant award for 140 Princes' Boulevard, Horse Palace, Exhibition Place, for the replication of doors in the amount of \$4,300.00 be approved and the Grant award be conditional on the applicant entering into a Restoration Grant Agreement prepared by the City Solicitor in consultation with the Manager, Heritage Preservation Services;
- (2) the Toronto Heritage Grant recipient be requested to acknowledge the financial assistance provided by the City of Toronto in all advertisements, brochures or construction signs relating to the restoration project; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

10.5 Proposed Sidewalk Heritage Project (All Wards)

Councillor Pantalone informed the Economic Development and Parks Committee that the event held with respect to this matter was extremely well attended.

10.8 2002 Commercial Research Grant Program (All Wards)

- (1) the \$8,010.00 remaining in the 2002 Commercial Research Grant Program budget be granted to the proposed Church-Wellesley Business Improvement Area for the development of a multi-year business plan, conditional upon:
 - (a) the proposed Church-Wellesley Business Improvement Area receiving final approval by Council at their November 26, 27, 28, 2002 meeting; and
 - (b) the Church-Wellesley BIA Board of Management, within 30 days of being established by Council, submitting a completed grant program application to the Commissioner of Economic Development, Culture and Tourism; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

(1) the Commissioner of Economic Development, Culture and Tourism report back in six months on the status of the visual identity program and capital improvement strategy for the Discovery District, including the creation of the Medical Walk of Fame; and

(2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (2) Schedule "A" of the City of Toronto Municipal Code Chapter 19, "Business Improvement Areas", be amended to reflect the change in the number of Board members from 16 to 17 for the Corso Italia BIA; from 13 to 14 for the Danforth BIA; from 6 to 7 members for the Hillcrest Village BIA; and from 8 to 10 members for the Mimico Village BIA; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

10.12 Intention to Expand the Kingsway Business Improvement Area Boundary (Ward 5 Etobicoke-Lakeshore)

- (2) the City Clerk be authorized and directed to send out a notice of Council's intention to pass a by-law designating the areas as an expanded Business Improvement Area, in accordance with Section 220 of the Municipal Act;

- (3) the Commissioner of Works and Emergency Services be requested to prepare a survey of the area as described by Attachment No. 1 and to submit this survey to the City Solicitor;
- (4) subject to the City Clerk reporting favorably on the results of the intention to pass a by-law designating the area (poll), referred to in Recommendation No. (2), and upon receipt of the survey prepared by the Commissioner of Works and Emergency Services, the City Solicitor be directed to prepare a by-law designating the areas as a Business Improvement Area as described by Attachment No. 1, in accordance with Section 220 of the Municipal Act; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Hall, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned report.

10.13 City of Toronto/Toronto Association of Business Improvement Areas (TABIA) Business Improvement Area (BIA) Operating Handbook
