Confirmation of Minutes

On motion by Don Altman, the minutes of the meeting of the Bid Committee held on March 1, 2006, were confirmed.

10.1 Request for Quotation (RFQ) 3809-05-0129 for the Inspection, Testing, and Maintenance of Fire Alarm and Sprinkler/Standpipe Systems in various locations throughout the City of Toronto

The Bid Committee considered a report (February 21, 2006) from the Acting Director of Purchasing and Materials Management, advising on the results of the Request for Quotation (RFQ) 3809-05-0129 issued for the supply of all labour, material, tools and equipment necessary to perform inspection, testing, maintenance and repair of fire alarm systems, sprinkler/standpipe, Inergen gas systems and related equipment for the period March 1, 2006 to July 31, 2008, and requesting the authority to issue contracts to the recommended bidders.

Recommendations:

It is recommended that:

- (1) that authority be granted to award a contract to Direct Fire Protection, in the amount of \$53,097.50 including all applicable taxes and charges, for the provision of the supply of all labour, material, tools and equipment necessary to perform inspection, testing, maintenance and repair of fire alarm systems, sprinkler/standpipe, Inergen gas systems and related equipment for the West District;
- (2) that authority be granted to award a contract to Richmond Fire Systems in the amount of \$174,861.00 including all applicable taxes and charges, for the provision of the supply of all labour, material, tools and equipment necessary to perform inspection, testing, maintenance and repair of fire alarm systems, sprinkler/standpipe, Inergen gas systems and related equipment for the East District and Police Buildings;
- (3) that authority be granted to award a contract to Collins Fire Systems in the amount of \$284,262.25 including all applicable taxes and charges, for the provision of the supply of all labour, material, tools and equipment necessary to perform inspection, testing, maintenance and repair of fire alarm systems, sprinkler/standpipe, Inergen gas systems and related equipment for the South District; and
- (4) that authority be granted to award a contract to Firetronics Component Service Ltd., in the amount of \$256,584.10 including all applicable taxes and charges, for the provision of the supply of all labour, material, tools and equipment necessary to perform inspection, testing, maintenance and repair of fire alarm systems, sprinkler/standpipe, Inergen gas systems and related equipment for the North and Downtown Districts.

On motion by Mike McCoy, the Bid Committee adopted the staff recommendations in the Recommendations Section of the report.

10.2 Request for Quotation 4205-05-5370 - Irrigation System Upgrades at Scarlett Woods Golf Course (Ward 11- York South-Weston)

The Bid Committee considered a report (February 24, 2006) from the Acting Director of Purchasing and Materials Management, advising on the results of the Request for Quotation issued for the Irrigation System Upgrades at Scarlett Woods Golf Course, in accordance with specifications, as required by the Policy and Development Division,

Parks, Forestry and Recreation, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award a contract to NLG Construction Ltd. & Gryan Construction Ltd., at a cost of \$629,788.99 including all applicable taxes and charges for the Irrigation System Upgrades at Scarlett Woods Golf Course.

On motion by Mike Harvey, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report.

10.3 Request for Quotation (RFQ) 6115-05-3298 - For the Supply and Delivery of Ten (10) latest model Triple Combination Pumper Trucks

The Bid Committee considered a report (February 20, 2006) from the Acting Director of Purchasing and Materials Management, advising on the results of the Request for Quotation 6115-05-3298 for the Supply and Delivery of ten (10) latest model Triple Combination Pumper Trucks for Toronto Fire Services, all in accordance with terms, conditions and specifications of the RFQ, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award a contract to Seagrave Fire Apparatus Company, in the amount \$4,343,254.12, including all applicable taxes and charges, for the supply and delivery of ten (10) latest model Triple Combination Pumper Trucks for Toronto Fire Services.
