Confirmation of Minutes

On motion by Laurie McQueen, the minutes of the meeting of the Bid Committee held on July 19, 2006, were confirmed.

30.1 Contract 06NY-108TR, Tender Call 69-2006 - "Cold In Place" Asphalt Recycling, (Ward 8, York West, North York District)

The Bid Committee considered a report (July 18, 2006) from the General Manager of Transportation Services and the Director of Purchasing and Materials Management, advising on the results of the Tender issued for "Cold In Place" Asphalt Recycling, Ward 8, York West, North York District, in accordance with specifications as required by the Transportation Services Division, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06NY-108TR, Tender Call 69-2006 "Cold In Place" Asphalt Recycling, Ward 8, York West, North York District, to Furfari Paving Co. Ltd., in the amount of \$1,376,156.93, including all taxes and charges, having submitted the lowest bid meeting specifications.

30.2 Contract 06NY-04RD, Tender Call 137-2006 - Road Resurfacing on Avenue Road from Lawrence Avenue to Wilson Avenue and Brookdale Avenue from Avenue Road to Elm Road, Including Coloured Impressed Bands on Asphalt Boulevard along Keele Street from Sheppard Avenue to Wilson Avenue (Ward 16, Eglinton-Lawrence and Ward 9, York Centre)

The Bid Committee considered a report (July 14, 2006) from the Executive Director of Technical Services and the Director of Purchasing and Materials Management, advising on the results of the Tender issued for Road Resurfacing on Avenue Road and Brookdale Avenue, including Coloured Impressed Bands on Asphalt Boulevard along Keele Street from Sheppard Avenue to Wilson Avenue, in accordance with specifications as required by Technical Services, and to request authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06NY-04RD, Tender Call 137-2006, for Road Resurfacing on Avenue Road and Brookdale Avenue, including Coloured Impressed Bands on Asphalt Boulevard along Keele Street from Sheppard Avenue to Wilson Avenue, to Gazzola Paving Limited, in the amount of \$3,946,101.75 including all taxes and charges, having submitted the lowest bid meeting specifications.

30.3 Contract 06NY-12RD, Tender Call 157-2006 - Road Reconstruction on Heddington Avenue from Eglinton Avenue to Roselawn Avenue and Bude Street from Vaughan Road to Alameda Avenue (Ward 15 and Ward 16, Eglinton-Lawrence)

The Bid Committee considered a report (July 17, 2006) from the Executive Director of Technical Services and the Director of Purchasing and Materials Management, advising on the results of the Tender issued for Road Reconstruction on Heddington Avenue from

Eglinton Avenue to Roselawn Avenue and Bude Street from Vaughan Road to Alameda Avenue, in accordance with specifications as required by Technical Services, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06NY-12RD, Tender Call 157-2006, for Road Reconstruction on Heddington Avenue from Eglinton Avenue to Roselawn Avenue and Bude Street from Vaughan Road to Alameda Avenue, to Il Duca Contracting Inc., in the amount of \$929,041.77, including all taxes and charges, having submitted the lowest bid meeting specifications.

On motion by Don Altman, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report.

30.4 Contract 06TE-18RD, Tender Call 158-2006 - Reconstruction and Resurfacing of Pavement, Replacement of Sidewalk and Water Services on Rawlinson Avenue from Roehampton Avenue to Broadway Avenue; Russell Hill Road from Chaplin Crescent to Eglinton Avenue West; College Street from Elizabeth Street to Spadina Avenue; and Intersection Improvement at Winona Avenue and Barrie Avenue, (Ward 20, Trinity-Spadina, Wards 21 and 22, St. Paul's and Ward 27, Toronto Centre-Rosedale)

The Bid Committee considered a report (July 17, 2006) from the Executive Director of Technical Services and the Director of Purchasing and Materials Management, advising on the results of the Tender issued for Reconstruction and Resurfacing of Pavement, Replacement of Sidewalk and Water Services on Rawlinson Avenue from Roehampton Avenue to Broadway Avenue; Russell Hill Road from Chaplin Crescent to Eglinton Avenue West; College Street from Elizabeth Street to Spadina Avenue; and Intersection Improvement at Winona Avenue and Barrie Avenue, in accordance with specifications as required by Technical Services, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06TE-18RD for Reconstruction and Resurfacing of Pavement, Replacement of Sidewalk and Water Services on Rawlinson Avenue from Roehampton Avenue to Broadway Avenue; Russell Hill Road from Chaplin Crescent to Eglinton Avenue West; College Street from Elizabeth Street to Spadina Avenue; and Intersection Improvement at Winona Avenue and Barrie Avenue, to CRCE Construction Ltd., in the amount of \$726,680.88, including all applicable taxes and charges, having submitted the lowest bid meeting specifications.

Recommendation:

It is recommended that authority be granted to award a contract for Tender Call 75-2006, for the Computer Distribution Centre Power Upgrade in the Consolidated Computer and Communication Centre at 703 Don Mills Road, to Comstock Canada Ltd., in the amount of \$784,604.58, including all taxes and charges, having submitted the lowest bid meeting specifications.

On motion by Vernon Chan, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report.

30.6 Tender Call 80-2006 - Fire Alarm System Replacement Metro Hall, 55 John Street

It is recommended that authority be granted to award a contract for Tender Call 80-2006, for the Fire Alarm System Replacement in the Metro Hall at 55 John Street to Rogol Electric, in the amount of \$2,791,775.00, including all taxes and charges, having submitted the lowest bid meeting specifications.
