47.1 Request for Quotation 3717-06-5304 - Landscape Upgrades at North Humber Park, Parks, Forestry and Recreation (Ward 1, Etobicoke North)

The Bid Committee considered a report (November 10, 2006) from the General Manager of Parks Forestry and Recreation and the Director of Purchasing and Materials Management, advising on the results of the Request for Quotation issued for the Landscape Upgrades at North Humber Park, in accordance with specifications as required by Parks, Forestry and Recreation, and requesting the authority to award a contract to the recommended bidder.
