## **Confirmation of Minutes**

### 28.1 Street Vendors

The Toronto Pedestrian Committee considered a presentation by Marianne Moroney, Executive Director of the Street Vendors Association, regarding street vending issues the association is working on with the city.

The Toronto Pedestrian Committee adopted the following recommendations:

- 1. That the Licensing and Standards Committee:
  - (a) be advised that the Toronto Pedestrian Committee supports licensed street vending in Toronto and believes that it contributes significantly to a vibrant pedestrian environment; and
  - (b) reconsider the moratorium on street vendors in the downtown area.
- 2. That the Planning and Growth Committee request the Chief Planner and Executive Director be requested to consider street vendors in the design of future streetscape improvements.

## 28.2 Street Hockey

The Toronto Pedestrian Committee considered a proposal from Matthew Blackett regarding the use of City streets for playing hockey.
