CITY OF TORONTO

BY-LAW No. 161-2015

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Ossington Avenue Business Improvement Area and to establish a Board of Management for the Ossington Avenue Business Improvement Area.

Whereas Council, by the adoption of By-law No. 538-2014, designated an area along Ossington Avenue between Dundas Street West and Queen Street West, as a business improvement area under Municipal Code Chapter 19, Business Improvement Areas; and

Whereas Toronto and East York Community Council has established a board of management for the Ossington Avenue Business Improvement Area and appointed members to the Ossington Avenue Business Improvement Area Board of Management for a term expiring on November 30, 2018, or as soon thereafter as successors are appointed; and

Whereas Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Ossington Avenue Business Improvement Area Board of Management;

The Toronto and East York Community Council enacts:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - (1) The table in Schedule A, Boards of Management, is amended by adding the new Ossington Avenue Board of Management as set out in Schedule A attached; and
 - (2) Schedule A, Maps, is amended by adding the attached map of the Ossington Avenue Business Improvement Area.
2. A Board of Management for the Ossington Avenue Business Improvement Area is hereby established.

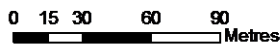
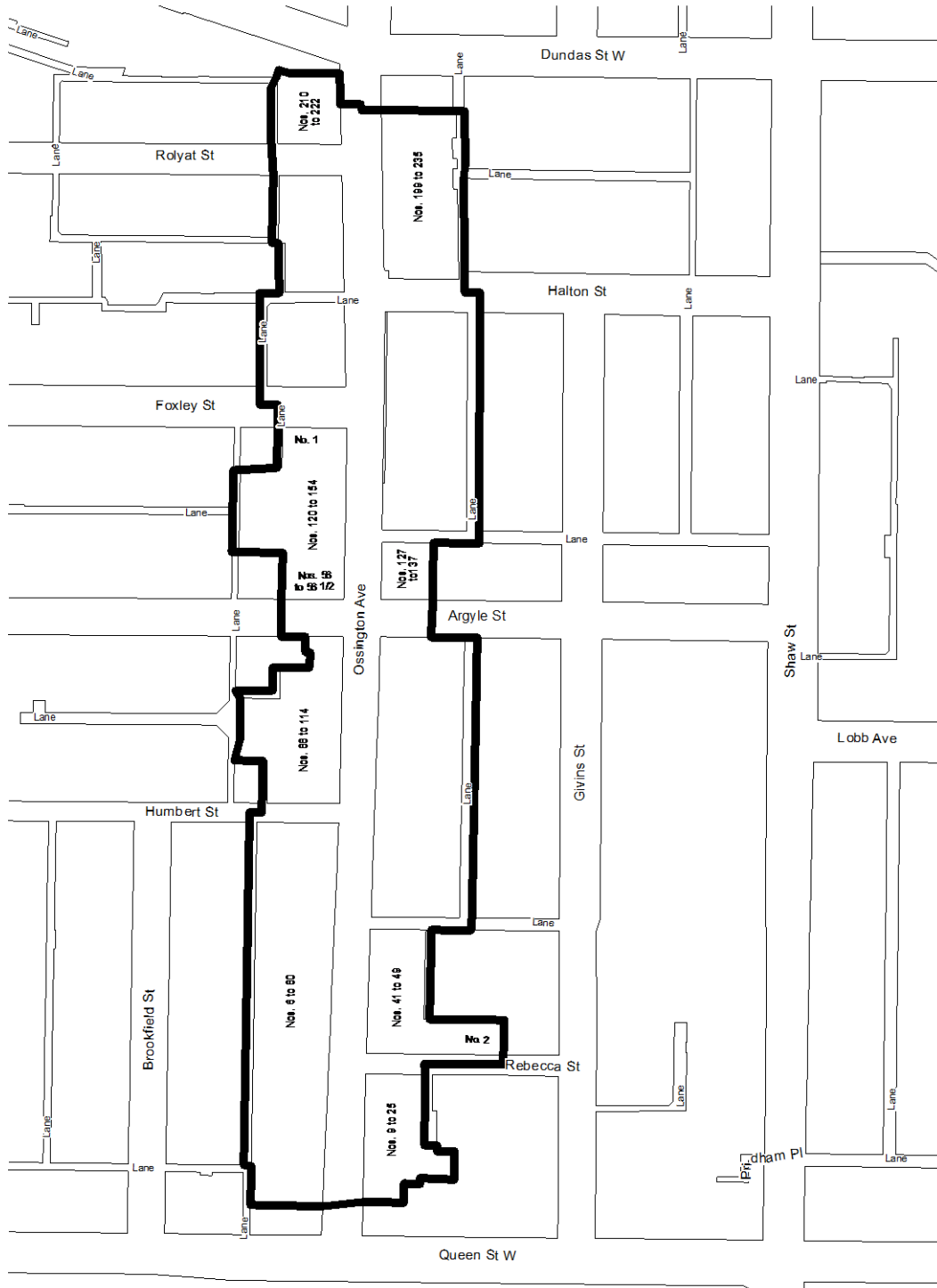
