CITY OF TORONTO

BY-LAW 565-2024

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Ashworth Avenue, Brenton Avenue, Golfview Avenue, Lonsdale Road, Melita Crescent, Queensdale Avenue, Shaw Street, Sorauren Avenue, Westlake Crescent and Wolverleigh Boulevard.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Brenton Avenue	South	A point 11 metres west of Meighen Avenue and a point 5.5 metres further west	Anytime
Melita Crescent	North	A point 24.5 metres east of the west of Melita Crescent and a point 5.5 metres further east	Anytime

- B. By inserting in Schedule II (Designated On-Street parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Ashworth Avenue	South	A point 73.5 metres east of Christie Street and a point 5.5 metres further east	Anytime
Golfview Avenue	East	A point 69 metres north of Cassels Avenue and a point 5.5 metres further north	Anytime, from the first day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Golfview Avenue	West	A point 77.5 meters north of Cassels Avenue and a point 5.5 metres further north	Anytime, from the 16th day to the last day of each month from April 1 to November 30, and from December 1 of one year to March 31 of the next following year, inclusive
Lonsdale Road	South	A point 40.5 metres east of Spadina Road and a point 5.5 metres further east	Anytime
Queensdale Avenue	North	A point 46.9 metres east of Linsmore Crescent and a point 5.5 metres further east	May, July, Sept. and Nov.
Queensdale Avenue	South	A point 43.5 metres east of Linsmore Crescent and a point 5.5 metres further east	Jan., Feb., Mar., Apr., June, Aug., Oct. and Dec.
Shaw Street	West	A point 21 metres south of Halton Street and a point 5.5 metres further south	Anytime
Sorauren Avenue	West	A point 24.5 metres south of Saunders Avenue and a point 5.5 metres further south	Anytime
Westlake Crescent	East	A point 55.6 metres north of Hamstead Avenue and a point 5.5 metres further north	Anytime
Wolverleigh Boulevard	South	A point 95.9 metres east of Woodington Avenue and a point 5.5 metres further east	Anytime
