**CITY OF TORONTO**

**BY-LAW 729-2024**

**To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Ardagh Street, Beresford Avenue, Bristol Avenue, Kenneth Avenue, Maria Street, Nairn Avenue, Rains Avenue, Shaw Street, St. Clarens Avenue and Windermere Avenue.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:

A. By deleting from Schedule III (Designated On-Loading Zones for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Ardagh Street	North	A point 27.8 metres east of Willard Avenue and a point 5.5 metres further east	Anytime
Beresford Avenue	East	A point 51.6 metres north of Colbeck Street and a point 5.5 metres further north	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Bristol Avenue	West	A point 158.3 metres north of Geary Avenue and a point 5.5 metres further north	Anytime
Kenneth Avenue	South	A point 59.3 metres east of Indian Road Crescent and a point 5.5 metres further east	Anytime
Maria Street	South	A point 48.9 metres east of Gilmour Avenue and a point 5.5 metres further east	Anytime
Nairn Avenue	East	A point 112.5 metres north of Chudleigh Road and a point 5.5 metres further north	Anytime
Nairn Avenue	East	A point 122.5 metres north of Chudleigh Road and a point 5.5 metres further north	Anytime

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
St. Clarens Avenue	East	A point 156 metres north of College Street and a point 5.5 metres further north	Anytime
Windermere Avenue	East	A point 101.5 metres north of Bloor Street West and a point 5.5 metres further north	Anytime

B. By inserting in Schedule III (Designated On-Loading Zones for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Rains Avenue	East	A point 11.8 metres south of Davenport Road and a point 5.5 metres further south	Anytime, from the 1st day to 15th day of each month, from Apr. 1 to Nov. 30, inclusive, and from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Rains Avenue	West	A point 17.2 metres south of Davenport Road and a point 5.5 metres further south	Anytime, from the 16th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive
Shaw Street	West	A point 54 metres south of Dewson Street and a point 5.5 metres further south	Anytime
