## **CITY OF TORONTO**

### **BY-LAW 1207-2024**

**To amend Table 6: Chapter 910, Parking Machines, Parking Meters and Mobile Only Zones, and Table 10: Chapter 950, Traffic and Parking, to City of Toronto Municipal Code Chapter 610, Penalties, Administration of.**

Whereas City Council on April 17 and 18, 2024 adopted with amendments Infrastructure and Environment Committee Item IE11.2, which recommended that City Council amend City of Toronto Municipal Code Chapter 610, Penalties, Administration of, increasing the penalty amounts generally as outlined in Attachment 1 to Motion 2 by Councillor Jennifer McKelvie with an implementation date of August 1, 2024; and

Whereas City Council on July 25, 2024 voted in favour of By-law 822-2024, being a by-law "To amend City of Toronto Municipal Code Chapter 610, Penalties, Administration of, to increase penalty amounts for parking offences and establish new electric vehicle parking offences for off-street parking facilities.", which by-law took effect on August 1, 2024, and which by-law inadvertently missed re-inserting a number of entries into Table 6, Chapter 910, Parking Machines, Parking Meters and Mobile Only Zones, to Chapter 610 and inadvertently included in Table 10: Chapter 950, Traffic and Parking, to Chapter 610 a duplicate entry for section 950-400L and inadvertently missed re-inserting 3 entries, one for each of sections 950-400L, 950-405B and 950-405E; and

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Council of the City of Toronto enacts:

1. City of Toronto Municipal Code Chapter 610, Penalties, Administration of, is amended by:
