Subject: Community Safety Investment Program (CSI) 2008 Allocation Recommendations

Recommendations:

The Community Partnership and Investment Program Appeals Sub-Committee recommends to the Community Development and Recreation Committee that:

- 1. The allocations for the Community Safety Investment program totalling \$651,820.00 to 24 applicants as recommended in Appendices A and B; be approved, and an amount of \$18,000.00 be held for appeals.**
- 2. The appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.**

Background:

The Community Partnership and Investment Program Appeals Sub-Committee on June 3, 2008, considered a report (May 16, 2008) from the Executive Director, Social Development, Finance and Administration Division, providing the recommendations for the organizations that applied for municipal support under the 2008 Community Safety Investment program; and noting that of the 75 applicants, 24 are recommended for funding totalling \$651,820.00, of which \$18,000.00 has been held for appeals.

Recommendations:

The Executive Director, Social Development, Finance and Administration Division, recommends that:

1. The Community Partnership and Investment Program Appeals Sub-committee approve the allocations for the Community Safety Investment program totalling \$651,820.00 to 24 applicants as recommended in Appendices A and B; and an amount of \$18,000.00 be held for appeals.
